

POSITION ANNOUNCEMENT Adjunct Instructor – Graduate Accounting

Instructors are required to facilitate the course using these materials and resources, which are provided to students via the Moodle learning management system.

- Nurture a positive online learning environment that fosters collegiality, critical thinking, personal growth, and mutual respect
- Effectively facilitate weekly course content, including all discussion forums and other learning activities
- Ensure completion of all learning outcomes as outlined in the course syllabus
- Regularly interact with students via weekly announcements and discussion forums
- Provide detailed and timely feedback on all student assignments
- Actively monitor student progress and timely completion of all assigned learning activities, and assist students as needed
- Identify at-risk students and refer them to appropriate academic support services
- Respond to all student questions and concerns in a timely manner
- Submit weekly attendance and final grades within required deadlines

Expectations for the Successful Candidate

- Evangelical Christian confession of faith and experience (Statement of Faith required at application)
- an earned doctorate in Accounting or related field from an accredited U.S. college/university
- industry experience in Accounting (preferred)
- exceptional interpersonal, oral presentation, and written communication skills
- engaging facilitation style and appreciation of successful instructional approaches for a range of student academic abilities
- proficiency in use of Microsoft Office (Moodle training will be provided)
