#### **Mount Vernon Nazarene University Campus Safety**

The Mount Vernon Nazarene University Campus Safety Office is committed to providing a safe and secure environment for faculty, staff and students. Maintaining a safe campus environment is not just the responsibility of the Campus Safety Office, but of all members of the MVNU community.

The Campus Safety Office is staffed 24 hours a day, seven days a week, 365 days a year. Campus Safety officers are trained and certified in CPR, First-Aid, and use of Automated External Defibrillators (AED).

#### **Timely Warnings**

Four lines of communication are available to announce an emergency that threatens the campus: Text to mobile devices, voicemail to mobile devices, email, and voice message to campus phones. Two or more of these will be used to announce any safety threat to students, faculty, and staff. MVNU's emergency webpage, mvnucrisis.wordpress.com, will provide relevant communication and updates throughout the emergency. Campus emergency personnel will use these lines of communication to provide information on the correct protective action to take place and provide updates on the emergency situation. Initial notification may be implemented by the Campus Safety office, Senior Leadership Team, the Residential Life office, or Graduate and Professional Studies office. The Senior Leadership Team will then implement the Campus Emergency Response Plan.

Depending on the particular circumstances of the emergency event, MVNU will implement one of six campus status descriptions: Campus open, campus closed, restricted access, shelter-in-place, evacuation, or lockdown.

Anyone with information warranting a timely warning should report the circumstances to Campus Safety, by phone at campus extension 8686, or 740-399-8686, or in person at the campus safety office. All students, faculty, staff, and visitors are encouraged to call 9-1-1 in an emergency.

PREPARATION OF DISCLOSURE OF CRIME STATISTICS – The MVNU Campus Safety Office prepares the MVNU Annual Campus Safety and Fire Safety Report to comply with the Jeanne Clery Disclosure of Campus Security Policy and Crime Statistics Act. The report is prepared in cooperation with the local law enforcement agencies surrounding our main campus, off-campus locations, and the office of Student Life. Each entity provides updated information on their educational efforts and programs to comply with the Clery Act.

Campus crime, arrest and referral statistics include those reported to Campus Safety, designated campus officials (including but not limited to directors, deans, department heads, judicial affairs, advisors to students/student organizations, athletic coaches), and local law enforcement agencies. These statistics may also include crimes that have occurred in private residences or businesses and is not

required by law. Department of Counseling and Psychological Services staff informs their clients of the procedures to report crime to Campus Safety on a voluntary or confidential basis, should they feel it is in the best interest of the client. A procedure is in place to anonymously capture crime statistics disclosed confidentially during such a session.

Each year, an e-mail notification is made to all enrolled students and MVNU employees that provide the web site to access the Annual Campus Safety Crime and Fire Safety Report. All prospective employees may obtain a copy from the website. Copies of the report may be obtained from the Campus Safety Department.

Timely and accurate reporting is crucial to ensuring a safe environment for the MVNU community.

<u>LIMITED VOLUNTARY CRIME REPORTING</u> - The Mount Vernon Police Department 740-397-2222 encourages anyone who is the victim or witness to any crime to promptly report the incident to the police. Because police reports are public records under state law, the Mount Vernon Police Department cannot hold reports of crime in confidence. Confidential reports for purposes of inclusion in the annual disclosure of crime statistics can generally be made to campus safety officers at 740-399-8686, MVNU extension 8686 other MVNU campus security authorities as listed below

HOW TO REPORT CRIMINAL OFFENSE – For non-emergency crimes, contact the Campus Safety Department at campus extension 8686 or off-campus phone 740-399-8686. For emergencies only, dial 9-1-1. Campus emergency phones are located at the main entrances to Pioneer dormitory, Oakwood dormitory, Galloway dormitory, Redwood dormitory, University main entrance welcome booth, and on the pathway leading to the Lakeholm Church of the Nazarene. Any suspicious activity or person seen in the parking lots or loitering around vehicles, inside buildings or around the Residential Halls should be reported to the Campus Safety. <u>CONCEAL CARRY AND WEAPONS ON CAMPUS</u> - The state of Ohio allows qualified citizens to carry concealed weapons, but only if certain strict conditions are met. The Concealed Carry Law <u>does not</u> allow concealed weapons to be anywhere on the premises of a University (Forbidden Carry Zone) unless the weapon is locked in an automobile or in the process of being locked in the automobile. It is against MVNU policy to carry a firearm, deadly weapon, or dangerous ordinance onto any Mount Vernon Nazarene University campus or into any Mount Vernon Nazarene University campus facility.

<u>CAMPUS LAW ENFORCEMENT</u> – Mount Vernon Nazarene University Campus Safety Officers have the authority to ask persons for identification and to determine whether individuals have lawful business at MVNU. Mount Vernon Nazarene University Campus Safety Officers have the authority to issue parking citations, which are billed to financial accounts of students, faculty and staff. Safety Officers do not possess arrest authority. Criminal incidents are referred to the local police who have jurisdiction on the campus. The MVNU Campus Safety Department maintains a professional working relationship with the Mount Vernon Police Department. All crime victims and witnesses are strongly encouraged to immediately report the crime to the MVNU Campus Safety Department at 740-399-8686 or campus extension 8686 and/or the Mount Vernon Police Department at 740-397-2222. Prompt reporting will assure timely warning notices on-campus and timely disclosure of crime statistics.

MEMORANDUM OF UNDERSTANDING — The Mount Vernon Nazarene University Campus Safety
Department maintains a close working relationship with the Mount Vernon Police Department for on campus incidents. The MVNU Campus Safety Staff works with other agencies in the Mount Vernon area including the Mount Vernon Fire Department, the Knox County Sheriff Department, and the Kenyon College office of Campus Safety. Meetings are held with representatives of these other agencies on a formal and informal basis. The MVNU Campus Safety Officers and the Mount Vernon Police Departments communicate regularly on the scene of incidents that occur in and around the main campus area. The MVNU Campus Safety Officers work closely with the investigative staff of the Mount Vernon Police Department when incidents arise that require joint investigative efforts, resources, crime related reports and exchange of information, as deemed necessary. There is no written memorandum of understanding between Mount Vernon Nazarene University, the Mount Vernon Police Department or other police agencies around off-campus locations.

<u>CRIMINAL ACTIVITY OFF CAMPUS</u> – Local criminal activity off campus is monitored by the Mount Vernon Police Department, Knox County Sherriff's Office, and the Ohio State Highway Patrol. Mount Vernon Nazarene University enjoys a close working relationship with these three agencies and a cooperative team approach addresses situations as they arise.

MISSING STUDENT NOTIFICATION – If a faculty, staff or student member of the Mount Vernon Nazarene University community has reason to believe that a student who resides in on-campus housing is missing, he or she should immediately notify MVNU Campus Safety at ext. 8686, or the Vice President for Student Life at ext. 4602, or a Student Life Resident Director, or Resident Assistant. Any of these contacts will generate a missing student report and initiate an investigation.

After investigating a missing person report, should Mount Vernon Nazarene University officials determine that the student has been missing for 24 hours, MVNU will notify the Mount Vernon City Police department and the student's emergency contact. If the missing student is under the age of 18 and is not an emancipated individual, MVNU will notify the student's parent or legal guardian immediately after MVNU has determined the student has been missing for 24 hours.

The 24 hour regulation does not preclude MVNU from contacting the student's contact person or their custodial parent or guardian immediately upon determination that the student is missing.

<u>MVNU SECURITY AND ACCESS</u> – With certain exceptions, Mount Vernon Nazarene University academic and administrative buildings are open to students, parents, employees, contactors, guests, and invitees during regular business hours, Monday – Friday, 8:00 a.m. – 4:30 p.m. Emergencies may necessitate changes or alterations to any posted schedule.

Galloway, Oakwood, Pioneer and Redwood residential halls are secured 24 hours a day with access via a door access control (card reader) system. Only students residing in these dormitories have access 24 hours a day, while other students have limited access during the day. Issuance of identification cards for door access is controlled by MVNU Campus Safety. Other residential apartments are locked by keys issued to students residing in the apartments.

Some MVNU facilities may have individual hours which may vary at different times of the year. In these cases, the facilities are secured according to the schedule developed by the department responsible for the facility.

MVNU Campus Safety conducts nightly checks of each non-residence facility to ensure the building is secured. Maintenance concerns noted by Campus Safety officers are reported to MVNU Facility Services. The officers walk and patrol residential and non-residential areas on a regular basis.

<u>ALCOHOLIC BEVERAGES</u> – The possession, sale, use, or furnishing of alcohol on the Mount Vernon Nazarene Campuses is governed by the Mount Vernon Nazarene University Alcohol Policy and the State of Ohio. Laws regarding the possession, sale, consumption, or furnishing of alcohol is controlled by the Ohio Department of Commerce Division of Liquor Control and other federal laws. The enforcement of alcohol policies on the MVNU campuses is the responsibility of MVNU Student Life, Campus Safety and

administration. MVNU campuses have been designated "Drug Free". The possession, sale, manufacture or distribution of any controlled substance is illegal under both state and federal laws. Such laws are enforced by MVNU policy. Violators are subject to Mount Vernon Nazarene University disciplinary action, criminal prosecution, fine, and imprisonment. It is unlawful to sell, furnish or provide alcohol to a person under the age of 21. It is contrary to MVNU policy to consume, sell, furnish or provide alcohol to anyone.

<u>ILLEGAL DRUG POSSESSION/USE</u> – Mount Vernon Nazarene University campuses have been declared "Drug Free". The possession, sale, manufacture, use or distribution of any controlled substance is prohibited under MVNU policy and is illegal under both state and federal law. The enforcement of alcohol policies on the MVNU campuses is the responsibility of MVNU Student Life, Campus Safety and administration. Violators are subject to Mount Vernon Nazarene University disciplinary action, criminal prosecution, fine, and imprisonment.

**SEX OFFENDER REGISTRATION** – In accordance with the "Campus Sex Crimes Prevention Act" of 2000, which amends the Jacob Wetterling Crimes Against Children and Sexually Violent Offender Registration Act, the Jeanne Clery Act and the Family Educational Rights and Privacy Act of 1974, the Mount Vernon Nazarene University Campus Safety Department is providing a link to the Ohio Attorney General Sexual Offender registry, This act requires institution of higher education to issue a statement advising the campus community where law enforcement information provided by the state concerning registered sex offenders may be obtained. It also requires sex offenders already required to register in a state to provide notice of each institution of higher education in that state at which the person is employed, carries a vocation, or is a student.

The State of Ohio Sex Offender registry is located at: <a href="http://www.ohioattorneygeneral.gov/">http://www.ohioattorneygeneral.gov/</a> at the bottom of the page, under the "Enforcement" section, click on the Sex offender search tab. Unlawful use of the information for purposes of intimidating or harassing another is prohibited and willful violation shall be punishable under Ohio law.

#### DISCLOSURES TO ALLEGED VICTIMS OF CRIMES OF VIOLENCE OR NON-FORCEABLE SEX OFFENSES —

Mount Vernon Nazarene University will, upon written request, disclose the alleged victim of crime of violence, or a non-forcible sex offense, the results of a disciplinary hearing conducted by the university against the student who is the alleged perpetrator of the crime or offense. If the alleged victim is deceased as a result of the crime or offense, Mount Vernon Nazarene University provides the results of the disciplinary hearing to the victim's next of kin, if so requested.

#### SEXUAL ASSAULT, DOMESTIC VIOLENCE, DATING VIOLENCE AND STALKING POLICIES -

Sexual assault, domestic violence, dating violence and staking are serious violations of law and University policy.

<u>Sexual assault</u>- means any offense classified as a forcible or non-forcible or non-forcible sex offence under the uniform crime reporting system of the Federal Bureau of Investigation, including rape, forcible sodomy, and sexual assault with an object, forcible fondling, incest and statutory rape.

<u>Domestic Violence</u>-includes asserted violent misdemeanor and felony offenses committed by the victim's current or former spouse, current or former cohabitant, and personal similarly situated under domestic or family violence law, or anyone else protected under domestic or family violence law.

<u>Dating Violence</u>- means violence by a person who has been in a romantic or intimate relationship with the victim. Whether there was such relationship will be gauged by its length, type, and frequency of interaction.

<u>Stalking</u>- means a course of conduct directed as a specific person that would cause a reasonable person to fear for her, his, or other's safety, or to suffer substantial emotional distress.

Title IX Liaisons have been appointed, some by virtue of their responsibilities and others by virtue of their location, to assist University members that may have been subjected to sexual discrimination, sexual harassment, or sexual violence. Liaisons will provide complainants with advice on protocols/procedures and provide consultation on appropriate courses of action. Liaisons include the following:

- Traditional students: Vice President for Student Life, and, if needed, a qualified staff person chosen by the Vice President for Student Life.
- GPS students: Vice President for Graduate and Professional Studies and Enrollment, and if needed, a qualified staff person chosen by the Vice President for Graduate and Professional Studies and Enrollment.
- Employees: Vice President for Academic Affairs (VPAA), Director of Human Resources, and, if needed, a qualified faculty or staff person chosen by the VPAA or Director of Human Resources.

#### **Grievance Resolution Procedures**

Any person enrolled at or employed by the University who (1) believes that s/he has been a victim of sexual discrimination, sexual harassment, or sexual violence and (2) seeks University resolution, is obligated to follow the below process. (If the incident warrants investigation by law enforcement authorities, the Director of Title IX Compliance will initiate contact.) Violations of this policy are subject to disciplinary action in accordance with university policy, the Faculty Handbook, Staff Handbook, and the Student Handbook.

<u>Step 1 – Consultation</u>: Complainants are to seek counsel and guidance early, before the alleged behavior escalates. Consultation will take place no more than 15 days after the incident or report of the incident. Complainants are to consult with a Liaison to gain perspective, seek direction, and, if necessary, discuss coping strategies. As these discussions are exploratory and definitional in focus, only a log is required. The Liaison will notify the Director of Title IX Compliance, who will keep the log. The log will contain the name of the complainant, the date of the consultation, and a brief description of the incident. Consultation is a prerequisite to Step 2.

<u>Step 2 – Informal Remediation</u>: If the complainant wishes to pursue the matter further, s/he will meet with the Director of Title IX Compliance no more than 15 days after the consultation (Step 1). (The complainant may request the assistance of a Liaison.) The Director will make inquiries of the accused

and may arrange for a mediation session of the parties together, at which the Director will preside. The goals of these discussions are to discuss the meaning of Title IX, identify inappropriate behavior, propose remediation, and develop plans to modify the policy or practice from which the behavior arose. It is expected that the entire informal remediation process be completed within 30 days after the consultation (Step 1). The Director shall keep a record of the matter, results of all meetings, and remedial actions. Informal remediation is a prerequisite to Step 3.

<u>Step 3 – Formal Grievance</u>: If the complainant deems the incident to be persistent or severe, or believes that informal remediation efforts have not satisfactorily resolved the matter, s/he may file a written complaint with the Director of Title IX Compliance. (The complaint may be filed by the complainant, his/her parent or guardian, or a third party on his/her behalf.) The complaint will be filed no more than 15 days after the informal remediation process (Step 2) is completed. (The complainant may request the assistance of a Liaison.) If necessary, the University may take interim remediation actions, which include, but are not limited to, the following:

- ensuring that the complainant and the accused do not attend the same classes;
- providing an escort to ensure that the complainant can move safely between classes and activities; and
- Moving the complainant and the accused to a different residence hall. Within 15 days of receiving the written complaint, the Director will conduct a formal investigation. The Director shall determine whether the facts support the allegations and, if so, recommend disciplinary action, up to and including expulsion from the University. The Director shall develop a detailed report that summarizes the allegations, the facts, and the recommended disciplinary action. The Director will inform the complainant and the accused of the outcome simultaneously, in writing, of any institutional disciplinary proceeding, the procedures for the victim and accused to appeal the results of the proceeding, any changes to the results and when such results become final. This shall be done within 5 days of the completion of the investigation. If it is impossible to inform the complainant and accused simultaneously in writing, the Director will keep a record of when notification to the complainant and accused was made and will note the reason why it was not possible to inform the complainant and accused simultaneously. Filing a formal grievance is a prerequisite to Step 4.

Note: The Director may request the assistance of a member of the Title IX Committee with the investigation. This individual may be asked to conduct or assist in the investigation. An individual serving in this role may not serve on the review panel.

<u>Step 4 – Review Panel</u>: Either the complainant or the accused may appeal the decision to a review panel. The appeal must be made within 5 days of the date on which the Director informs the appellant in Step 3.

The panel shall consist of five (5) individuals from the Title IX Committee. The Director of Title IX Compliance shall choose these individuals and designate the panel chair. The panel shall not be comprised of individuals who are all the same gender. The Director shall not serve on the panel.

If the allegations involve a GPS student or GPS faculty member, the panel shall include at least one individual who is connected with GPS. A Title IX Committee member who is named in a complaint shall be disqualified from serving on the panel. (The same holds true if a Title IX Committee member's immediate family is involved in the incident or its investigation.)

The complainant and the accused may invite one advisor of choice to the review panel hearing. (For the complainant, this may be a Liaison.) The advisor's role is consultative only; the advisor is not permitted to question hearing participants or make public comments to participants in the hearing.

The review panel hearing shall be conducted in accordance with the following procedures:

- The chair will convene the meeting, introduce the individuals, give a brief description of the process, and invite questions about the process.
- The chair will read the allegation(s) and call for the report of the Director of Title IX Compliance.
- The Director will submit the report as evidence and discuss same.
- Members of the panel may question the Director.
- The complainant may read a brief initial summary statement.
- The accused may read a brief initial response statement.
- The complainant may present evidence and witnesses regarding the allegations.
- The accused may present evidence and witnesses regarding the allegations.
- The complainant may present a brief final summation.
- The accused may present a brief final summation.
- After the hearings are completed, the panel shall deliberate in unrecorded executive session, during which it will consider the evidence, establish findings, develop sanctions and/or recommendations, and include an appropriate time frame within which the sanctions and/or recommendations will be carried out.
- Within 10 days of the close of the hearings, the chair will submit a written report that summarizes the findings, sanctions and/or recommendations, and time frame to the following individuals: complainant, accused, Director of Title IX Compliance, and appropriate Vice President the Vice President (in consultation with the President) will take the necessary action to resolve the issue within the time defined in the chair's report the panel determination is final and nonappealable. The chair will inform the complainant and the accused of the Review Panel's written report simultaneously. If it is impossible to inform the complainant and accused simultaneously in writing, the Chair will keep a record of when notification to the complainant and accused was made and will note the reason why it was not possible to inform the complainant and accused simultaneously.

Other review panel and hearing considerations are as follows:

- To prevent the hearing from being traumatic or intimidating to the complainant or the accused, questioning will be restricted to the panel – the complainant and the accused cannot crossexamine or question each other or any witnesses.
- With the exception of the advisor chosen by the complainant and accused, other individuals
  considered external to the appeal, including, but not limited to parents, relatives, media
  representatives, and guests are not permitted to participate in any way or attend any meetings
  or hearings.
- The complainant's burden of proof shall be "a preponderance of the evidence" (i.e., more likely than not), rather than the higher "beyond a reasonable doubt" standard that is required in criminal cases or the "clear and convincing" standard that is found in some civil cases.
- If the complainant expresses discomfort or requests isolation, the chair will provide for separation of the complainant and the accused during the hearing.

- Due to state and federal laws that protect the complainant from inquiry about prior sexual history (i.e., rape shield laws), the complainant may not be questioned about prior sexual history.
- If the panel determines that permanent separation orders are appropriate, the appropriate supervisory personnel are responsible for implementing same.
- Panel members are to maintain confidentiality of the information presented in the hearing and their deliberations – all communications to the campus or beyond must go through the chair – all records related to the matter shall remain confidential and subject to release only to the panel and the SLT member, unless otherwise required by law.
- Within a reasonable time after the hearing, the Director of Title IX Compliance will conduct a
  post-incident follow-up with the complainant and provide a written summary to the SLT
  member.
- If necessary, the panel shall consult with the University attorney.

The following matters are endemic to sexual harassment and sexual violence:

- The complainant may bypass or end Step 1 or Step 2 at any time and proceed directly to Step 3.
- Mediation (this is part of Step 2) of complaints alleging sexual assault or sexual violence is not appropriate under any circumstances.
- Complainants have the right to have the incident investigated by law enforcement authorities,
  have full and prompt cooperation and assistance in obtaining evidence necessary for proof of
  criminal acts (including a medical examination), and have the accused tested for communicable
  diseases the Director of Title IX Compliance will inform the complainant as to how to contact
  law enforcement authorities and will assist in the process, if the complainant requests.
- If law enforcement authorities are involved, the Director of Title IX Compliance will request access to their notes any agreement between the University and law enforcement authorities must allow the University to meet its Title IX obligation to promptly investigate complaints, even though it may delay University fact-finding interim remediation actions, if any, will remain in effect during this time.
- The University will treat all complainants with respect, whether or not they wish to pursue the
  matter with law enforcement authorities, make their options clear, Title IX Policy Page 10
  cooperate with them in exercising their options, and assist them in the investigation –
  complainants should be treated physically and emotionally in a timely and proper manner and
  be made aware of the importance of preserving evidence that may be necessary to the proof of
  a criminal act.
- All students and employees of MVNU who report that they have been the victim of an incident
  of sexual violence will be provided with a one page document describing their rights and
  options.
- The Director of Title IX Compliance will inform the complainant about who to contact to file for a protection/restraining order.
- While the complainant may request confidentiality, s/he needs to know that the request will be weighed against the seriousness of the allegation(s), that the University's ability to respond may be limited, and the FERPA rights of the accused might be implicated.
- Regardless of the action or lack of action by law enforcement authorities, the University will
  discipline individuals who are accused of sexual harassment or sexual violence based on the
  evidence it has before it.

- Complainants should immediately report the incident to a Resident Director, a Resident
  Assistant, a Counselor, medical or safety personnel, or the police emergency 911 service is
  available to report a crime in progress.
- Complainants have the right to be free from pressure from University authorities to report crimes as lesser offenses.
- Counseling and mental health services (some fee-based and some for no charge) are available to complainants, both on the main University campus and in the community.
- A full-time registered University nurse is normally available each weekday during the academic year in the event of the nurse's absence or when evening and weekend medical services are needed, these services may be obtained by contacting MVNU medical or safety personnel.
- Chaplaincy services are available at every University location.
- The University does not provide legal services to faculty, staff, or students.
- If a resident student feels physically or sexually intimidated, s/he should report this to his/her Resident Director s/he may request a change in academic and living situations, if such changes are reasonably available.
- By law, when complainants are under 18 years of age, the Director of Title IX Compliance will
  immediately notify the parents or guardians, the appropriate state agency, and law enforcement
  authorities.

# MONITORING AND REPORTING OF CRIMINAL ACTIVITY AT OFF-CAMPUS STUDENT ORGANIZATIONS -

Mount Vernon Nazarene University does not have any officially recognized student organizations with an off-campus housing location.
