

Parking Defined

A stationary, unoccupied vehicle.

Regulations

The number of motor vehicles parked and operated on campus requires effective management for the overall safety of the campus community. We commit to providing a space for everyone, but it is not possible to provide everyone a space that is close to their final destination or most convenient for them.

Where You May Park

See the MVNU parking map for indications of where members of the campus community and visitors may park.

Registration

Vehicles may be registered at my.MVNU.edu. Changes in vehicle information may also be entered at this site. Your parking tag may be picked up at the campus safety office.

Commuter/Post Secondary Parking

North and south chapel lots and behind the Cougar Corner Bookstore. Commuters may park in Hyson Campus Center lot after 4:30 p.m.

Handicapped/Medical Parking

A handicapped/medical parking pass may be obtained from the University nurse at ext. 4632. Several handicapped parking spots are available near almost every campus building.

Student Worker Parking

Students working in various departments on campus are to park in their regular residential lot during the day, not in yellow faculty or staff parking spaces.

Motorcycle Parking

Motorcycles must be parked in vehicle parking spot, not in the shelters provided for bicycles. Motorcycles parked in these shelters will be towed at the owner's expense.

Bicycle Policy

Bicycles must be registered with Campus Safety. Bikes must be parked in the bike sheds at the various living quarters or in bike racks. Locking bikes for protection is recommended. Bike serial number is needed in order to register a bicycle.

Visitors may park anywhere on campus, although there are three lots that have some designated visitor spots. Each department will be responsible for visitor parking passes.

VEHICLE REGISTRATION

Registration Required

Students need to register their vehicles every year (one vehicle per student). This can be done online (after confirming) at my.MVNU.edu (Student Pages, About Me, Vehicle Registration). Your license plate number is needed. If siblings share a vehicle, please let Campus Safety know so that two parking permits may be issued.

The only acceptable proof that a vehicle is properly registered is the display of the appropriate permit in the manner described at the right.

Any change in vehicle information must be reported immediately to Campus Safety by e-mailing campussafety@mvnu.edu or by calling (740) 397-9000, ext. 4460.

Displaying Permit

Parking permits must be attached to the vehicle and displayed in the lower passenger's side corner of the front windshield.

Failing to register a vehicle, display the parking permit, or abide by MVNU parking guidelines may result in a citation, or a vehicle being towed or booted at the owner's expense. A vehicle is not considered registered until the permit is properly affixed to the vehicle.

Temporary Parking Permit

A temporary parking permit should be obtained from Campus Safety for rented or borrowed vehicles that will be used temporarily.



PARKING VIOLATIONS

Registered Owner's Responsibility

The registered owner of a vehicle is responsible for its operation on campus. Any citations issued involving registered vehicles are the ultimate responsibility of the registered owner. Traffic fines are paid at Student Accounts in Founders Hall.

Violations

Parking in no-parking zone.....	\$20
Parking/driving on grass, sidewalks, or courtyards.....	\$20
Parking in lot other than designated on decal.....	\$20
Failing to display or improper display of decal	\$20
Parking in faculty/staff parking	\$20
Failing to register a vehicle.....	\$100
Failing to stop at a stop sign	\$50
Fire lane violation.....	\$50
Reckless driving/speeding.....	\$50
Failing to stop for a campus safety officer	\$50
Wrong way on one way street.....	\$20
Handicap parking violation.....	\$50
Blocking dumpster access.....	\$50
Boot removal plus violation.....	\$75

A second offense of the same violation will result in the fines being doubled.

Citations may be appealed within three school days. These may be submitted at www.mvnu.edu/cgi-bin/citationappeal.pl

Avoid Parking Fines

- Register your vehicle.
- Read e-mails sent regarding campus parking.
- Communicate with Campus Safety as soon as possible if a problem arises.
- Please park in designated assigned lot and walk to your destination.
- On weekdays yellow lined spaces are for faculty/staff parking only.
