Terms & Conditions

Mount Vernon Nazarene University (MVNU) with Worth It Moments (WIM)

Dates: Sept 29th through October 5th, 2025

Cost: \$1,495 per person

Price:

\$1,495 is based on shared double room occupancy and includes transportation, entrance fees to sights, and gratuities, and all meals except three. The single occupancy rate for individual travelers without a roommate is \$1,875

Deposit and Registration:

A non-refundable deposit of \$250 per person is required upon registration. Trip balance must be paid in full by July 1, 2025.

Payment Schedule:

Nonrefundable Deposit: Due December 1st, 2025

- Couple \$500
- Individual traveler \$250

Second Payment: Due March 19, 2025

- Couple \$1,500
- Individual traveler with roommate \$750 or without roommate \$1,130

Final Payment: Due June 3, 2025

- Couple \$990
- individual traveler \$495

Refunds Upon Cancellation:

Initial \$250 deposits are non-refundable. The refund cancellation (not including deposit) schedule is as follows:

- I. 75% refund on cancellations made 120+ days before the trip
- II. 50% refund on cancellations 90+ days before the trip
- III. 25% refund on cancellations made 30+ days before the trip
- IV. Cancellations within 30 days of the trip are not eligible for a refund

Insurance:

Both MVNU & Worth It Moments highly recommend purchasing insurance for trip cancellation and interruptions.

Physical Activity:

You acknowledge and agree that the travel will require moderate physical activity, some stairs, as well as sitting and standing for extended periods of time.

Compliance with Laws:

In the event MVNU & WIM need to postpone or reschedule the tour due to an event within our control, options will be given for a refund. In the event MVNU & WIM need to postpone or reschedule due to an event outside our control, refunds may not be able to be issued.
