Asst. Professor – STEM (MIS, Cybersecurity, Emerging Tech.)

- as internships, capstone projects, and research collaborations. Integrate ethical, legal, and security considerations into course instruction.
- Participate in faculty development programs and stay updated with advancements in technology and pedagogy.
- Serving the University through committee participation and other assigned tasks.
- Other duties as assigned.

- Master's degree (or foreign equivalent) in Management Information Systems, Cybersecurity,
- Computer Science, Data Science, or a related field.
- Christian statement of faith, experience, and mission fit.
- Personal commitment to Jesus Christ.
- Understanding and alignment of the heritage, doctrine, and practices of the Church of the Nazarene.
- Must be a minister in good standing with the Church of the Nazarene.
- Experience working with international populations and understanding their unique challenges and needs.
- Previous experience in campus ministry education, student services, or a related field is highly desirable.
