



POSITION ANNOUNCEMENT
Adjunct Instructor – Graduate Business Data Analytics

Mount Vernon Nazarene University exists to shape lives through educating the whole person and cultivating Christ-likeness for lifelong learning and service.

Mount Vernon Nazarene University (MVNU) is an intentionally Christian teaching university for traditional age students, graduate students, and working adults who seek opportunities to learn and grow in an academic community of faith. The University provides the context for a transformational experience through excellent academics, service opportunities, caring relationships, and a nurturing spiritual and social environment. Faculty, staff, and students are challenged to achieve their highest potential, to become increasingly Christ-like and to make a difference in their world through lifelong service.

The University seeks a part-time **Adjunct Instructor in Business Data Analytics** for the College of Adult and Professional Studies (CAPS) to teach courses to international students in both hybrid and online formats. All graduate courses utilize pre-developed, standardized curricula (includes textbook selection, course syllabus, grading scale, and all learning objectives, assignments, assessments, and activities). Instructors are required to facilitate the course using these materials and resources, which are provided to students via the Moodle learning management system. **Instructors are also required to attend residency for each in-seat course, which consists of one to two days of in-class instruction on campus.**

Responsibilities for this position include:

- Nurture a positive online learning environment that fosters collegiality, critical thinking, personal growth, and mutual respect
- Effectively facilitate weekly course content, including all discussion forums and other learning activities
- Ensure completion of all learning outcomes as outlined in the course syllabus
- Regularly interact with students via weekly announcements and discussion forums
- Provide detailed and timely feedback on all student assignments
- Actively monitor student progress and timely completion of all assigned learning activities, and assist students as needed
- Identify at-risk students and refer them to appropriate academic support services
- Respond to all student questions and concerns in a timely manner
- Submit weekly attendance and final grades within required deadlines

Expectations for the successful candidate:

- Evangelical Christian confession of faith and experience (Statement of Faith required at application)
- An earned doctorate in Business Data Analytics or related field from an accredited U.S. college/university
- A minimum of 18 credit hours in statistics-related coursework documented via transcripts
- Industry experience in Finance (preferred)
- Exceptional interpersonal, oral presentation, and written communication skills
- Engaging facilitation style and appreciation of successful instructional approaches for a range of student academic abilities
- Proficiency in use of Microsoft Office (Moodle training will be provided)

In a continuing effort to enrich its academic environment and provide equal educational and employment opportunities, the university actively encourages applications from members of all ethnic groups underrepresented in higher education. Applications will be accepted until the position is filled; however, early application is strongly advised. Interested candidates should send an application letter, curriculum vita, unofficial college transcripts, evidence of teaching competence, names and contact information for three references, a one-to two-page statement of educational philosophy, and a one-to two-page statement of faith.
